We still have an outstanding bill of \$10,500 to Kokes Construction.

Amy recommended that we pay \$5,000 towards the Kokes bill with funds in the PayPal camping account. Motion by Paul to pay the \$5,000, second by Ashley. Motion carried.

NRD will reimburse at % of the dam repair, once all bills have been paid and all receipts turned.

The endowment has \$98,969.50 in there currently. There will be about \$2,500 - \$3,000 of interest to spend this year. We have a 2 year window to spend the interest or it gets applied to the principal and untouchable then. The county will have the exact amount available after July 1st.

Old Business

Election: Joe Wadas, Amy Gizinski, Chris Levander and Donna Uhrenholdt's terms are up. Donna & Chris are stepping down this year. We would like to thank them for their years of volunteering. Joe and Amy will be running for re-election and Cindy Schure will be running.

Discussed lowering the number of board members from 12 to 9. Will discuss this further at the annual meeting.

John Schure delivered 2 loads of white rock to the lake. It is being distributed around the dam turn around and pot holes around the lake.

Update on lawsuit- We now have a mediation date set for June 24th. There was a conference call with the Judge scheduled for June 21st. Joe, Norm, Paul and Tom will be able to addend the mediation.

Annual Newsletters went out the first week of June. Some people have not received their letters. We will have a sign in at the annual meeting for everybody to give us updated address and email address to update or list.

New Business

Game & Parks Commission is going to deliver cat fish to the lake in the next 3-4 months. They had some concerns about us lowering the lake a year or so back. Joe informed them that we had to lower it to make some repairs. They would like to make sure water levels are maintained to support fish population if they are going to stock the lake at all.

There has been a heavy request for more playground equipment at the lake. There are a lot of new families with younger kids around the lake. Campers have also requested some playground equipment for kids at the campsites not just at the lake park.

Ben & Cindy Edwards are hosting a pancake feed – free will donation to raise funds for playground equipment.

The Levander family who donated the current park are fine with additional equipment, however they do request that it is good qualify equipment and nothing cheap.

Nick brought up that it had been approved in a past years meeting to approve funds for playground equipment. Funds were needed for the lawsuit and playground equipment is still high on our priority once funds are available. This is also something the events committee has on their list once we complete the storm shelter project.

Tom brought up that we need to be watching our water usage at the lake with heavy watering. During the drought a few years back people with shallow wells had issues with no water. If anybody is having any issues please let us know. We will continue to watch water levels.

It was suggested since we are getting caught up financially. The \$X of interest we get to use from the endowment that has to actually go towards something, we use those funds pay Kokes Construction bill, and then we take matching funds from our general account and put into the other account we have and

start building an account to dredge the lake. It will need to be done again in the next few years, after the floods last year there are several very shallow spots in the lake again.
